# Report on the progress made in attaining the goals of the wellness policy (REQUIRED):

Goal I: \*HGMICS has participated in Pennsylvania Harvest of the Month (PA HOM) since launch for the 2020-21 School Year. Our school celebrates each monthly item by incorporating it into school lunches, food samplings and educating our student population. We also educate families through our monthly Food Service News email posting to the social media page.

Goal II: \*HGMICS hosted it's first virtual Family Wellness cooking class promoting nutritious education. Taught by a Dietitian, families were given a shopping list and preparation instructions prior the zoom class. Families, along with their children, were given a brief background of each food item and the nutritional important of incorporating into their diets.

Goal III: \* Promotes a social emotional climate for all students attending HGMICS. The Social Emotional Learning (SEL) curriculum and social emotional learning is integrated into all academic subjects we supplement our MTSS and PBIS programs.

Goal IV: \* The Wellness Committee conducts an annual School Health Assessment with Action for Healthy Kids and analyzes data about school health, school meals, smart snacks, health education & physical education, physical activity, social emotional climate, employee wellness, and family/community involvement. This data is used for our continued compliance in promoting wellness initiatives.

Goal V: \*Assessments of the physical health of all students will be completed to aid in future planning. Progress: The School's Physical Education teacher assessed the fitness of students at the beginning and end of each school year using FITNESSGRAM Healthy Fitness Zone Performance Standards. Data is used in future programming.
