

## **Howard Gardner Multiple Intelligence Charter School**

### **Public Board Meeting**

Tuesday, February 21, 2023

The Howard Gardner MI Charter School (HGMICS) held a public Board of Trustees meeting on Tuesday, February 21, 2023. Stephanie Westington, President, called the meeting to order at 7:01 p.m. Stephanie led those assembled in the Pledge of Allegiance and took roll call for the board members and non-voting attendees.

#### **I. Minutes**

**Stephanie Westington**

Stephanie Westington presented the January 21, 2023 Board of Trustees meeting minutes and asked for approval. A **MOTION** to approve the January 21, 2023 Board meeting minutes, as submitted, was made by Susan Hennemuth and seconded by Sam Ceccacci. Stephanie asked if there were any comments or corrections on the minutes. Not hearing any, Stephanie called for a vote. All Board of Trustees members present voted in favor of approving the January 21, 2023, minutes as submitted, with one Trustee absent.

#### **II. President's Report**

Stephanie Westington welcomed everyone in attendance to the February 2023 Public Board meeting. Stephanie reported the School was awarded \$140,000 in grant funds from the Pennsylvania Commission on Crime and Delinquency. Grants from this fund will promote two very important areas, school safety and student mental health. With the School's business manager, John Marsico, on medical leave, the January financial report will be deferred and presented at the March Board Meeting. Howard Gardner Multiple Intelligence School's enrollment lottery for the school year 2023-24 is scheduled for March 1, 2023, for which Stephanie announced she will be present. Also, an Employee Recognition Event is scheduled for May 11, 2023, held at Glenmaura Country Club. Stephanie thanked trustee, Dr. Catherine Richmond-Cullen, for being a sponsor of this event. Lastly, Stephanie welcomed Ms. Melissa

Cruise, Howard Gardner Multiple Intelligence School's Art teacher, to present an educational presentation.

### **III. HGMICS Educational Session – “Why T.A.B.?”**

**Ms. Melissa Cruise**

Ms. Melissa Cruise, Howard Gardner Multiple Intelligence Charter School's Art teacher, presented on how she incorporates the T.A.B. (Teaching for Artistic Behavior) method of teaching in her art classes and why she believes in this method of teaching for Middle School students. Ms. Cruise described the process of letting her students choose their own projects and the positive attributes that accompany this teaching style. By letting students have choice and options they are more likely to embrace their creativity and thrive in school and outside of school when it comes to their creative impulses. Ms. Cruise stated that for students in the Elementary grades she focuses on skill building, which prepares them for choice-based art in grades 5-8.
